

MISS INTER-MOUNTAIN FAIR SCHOLARSHIP PROGRAM APPLICATION

The 60th Annual Inter-Mountain Fair Scholarship Program will be August 29, 2024 at the fairgrounds in McArthur. All entries must be complete and in the fair office on or before June 7th, 2024.

Contestants are expected to be at every practice, the final week is mandatory. They are also expected to be present for publicity pictures. Girls will be notified of dates and times. The practice schedule is as follows:

Contestants are asked to ride in a float for the Burney Basin Days Parade and attend Lassen County Queen Pageant in Susanville on July 17, 2024. There may be other trips such as a shopping day and other events as determined. There will be more information on these trips later.

Contestants will be judged on the following:

• Communication Skills Able to communicate effectively. Ability to be a good public

relations representative.

30% = Speech, 10% = Impromptu Question

• Visual Poise / Confidence Should walk and move freely, good posture, gracefulness,

good grooming and overall appearance.

<u>15% = Self Confidence</u>

• **Personality** Self Expression, ability to converse, be at ease, perception,

attitude and pleasantness.

30% = *Interview*

• Participation Attends and participates in all practices and events.

<u>15% = Participation</u>

Judges will conduct interviews prior to the pageant. Contestants will wear a business style suit during interviews.

Contestants will be judged in formals, casual wear and western wear during the program. Formals will be floor length. No accessories such as hats, parasols, gloves, etc. may be worn with formals. No Hats will be worn with western wear. Simple jewelry is acceptable. Sponsors are to see that their contestant has the necessary apparel. Each contestant will be allowed to have one backstage attendant during the pageant. Contestants must bring all clothing to be approved by the pageant coordinators.

The Queen will receive a \$1000 Scholarship. The two runners up will receive a scholarship of \$750 and \$500 respectively. A "Miss Congeniality" will be chosen by the contestants and will receive a bracelet and sash.

The Queen and court duties will include posing for publicity pictures, appearances at parades and other promotional activities to advertise our 105th Annual Inter-Mountain Fair. The Queen and court shall take part in

all activities during the fair, August 29 - September 2, 2024. Specific duties will include such things as presenting trophies and ribbons, organizing and conducting the Kids Day Activities, and appearing in the parade and the Royal Tea Party.

Scholarship Program Judges are chosen by the Fair Manager. They are from out of the area and do not have any contact with the contestants before the night of the pageant.

The participation score will be calculated by the Scholarship Program Coordinators. Each contestant will earn a point for each practice (excluding the mandatory practices) and a point for being at the Burney Basin Days Parade, attending the shopping day, and for attending the Lassen County Scholarship Program. Contestants will be allowed to miss only 1 practice without being docked any participation points. All other missed practices will be points deducted from the contestant's participation score. Please see **Participation Criteria** for rules and dates.

INTER-MOUNTAIN FAIR SCHOLARSHIP PROGRAM 2024 Rules & Regulations

- 1. Contestant must have reached their 16th but not their 20th birthday before September 1, 2024.
- 2. Contestant must be a resident of the Fall River Joint Unified, Big Valley, Mountain Union or Indian Springs School Districts.
- 3. Previous contestants may not enter again.
- 4. Entries are limited to the first twelve applicants with completed entry forms. Entry Forms are due to the fair office by June 7th, 2024.
- 5. All Contestants must have at least one sponsor and no more than five sponsors. A sponsor may be an organization, business or individual.
- 6. Contestant cannot be engaged, married, or ever have been married. Contestant must not be nor have been pregnant.
- 7. As a Representative of the Inter-Mountain Fair either as a contestant and/or royalty, you are expected to adhere to certain standards of conduct within the community. As determined by the Scholarship Program Committee any violation or misconduct at a school or public function will result in a forfeit of your eligibility of scholarship and title.
- 8. Contestant must be willing to serve as Official Host of the Inter-Mountain Fair whenever needed and represent the Inter- Mountain Fair during the subsequent year until a new representative is named.
- 9. Use of Alcohol and/or tobacco at any pageant function is cause for immediate disqualification.
- 10. Contestant cannot run for another contest or title during preparation for the Inter-Mountain Fair Scholarship program.
- 11. Contestant agrees to be on time and participate in a series of scheduled activities, events and designated competitions leading up to the final competition.
- 12. Contestant understands the Inter- Mountain Fair will not be responsible for any lost or stolen articles during competition activities from time of arrival to time of departure.
- 13. The Scholarship money will be held by the Inter-Mountain Fair until recipient shows proof, with an official transcript, of completing a semester or quarter equivalent at a college, university or trade school. Recipient must have maintained a 2.5 G.P.A. and have attended three designated representation activities not including the Inter- Mountain Fair.
- 14. The Scholarship money must be redeemed within 5 years of being awarded.
- 15. All Inter-Mountain Fair Scholarship program judge tally sheets and other materials are the sole property of the Inter-Mountain Fair and will remain strictly confidential.
- 16. The Inter-Mountain Fair reserves the right to reject any entrant who does not comply with the rules & regulations as well as providing false information on application.
